

ACKNOWLEDGMENT AND EXPRESS ASSUMPTION OF RISK AND RELEASE OF LIABILITY

I understand that during my visit to Little Creek Community Preserve and Little Creek Plantation (“Little Creek”) and participation in activities while at Little Creek, I may be exposed to a variety of risks and hazards, both foreseen and unforeseen. These are inherent in my visit and cannot be diminished without affecting or destroying the unique experience available at Little Creek.

Inherent risks include (but are certainly not limited to) the risk of serious personal injury to myself or others, property damage and death (“Injuries and Damages”) as a result of exposure to animals, snakes, insects, poisonous plants, the elements, the use of firearms, operating farm equipment and machinery, participating in the acts of hunting, target shooting, fishing and/or traversing the terrain either on foot, horseback or machine. No owner, member, officer, director, agent or employee of Little Creek has attempted to contradict or minimize my understanding of these risks.

I know that Injuries and Damages can be the result of natural causes and/or the activities of myself, other persons, animals, snakes, insects and poisonous plants, either directly or indirectly, as a result of negligence or other reasons. I know and understand that the risk of such Injuries and Damages are involved in my visit to Little Creek and I fully understand and acknowledge that I must reserve extra caution and care for my own person and those persons around me while visiting Little Creek.

In consideration of my visit to Little Creek and the services and amenities that may be provided to me, I acknowledge and confirm my full understanding of the following:

1. I have read and fully understand any rules and/or regulations affecting the activities in which I will be participating while visiting Little Creek.
2. I understand and acknowledge that the roads within Little Creek are private and do not meet county standards that would apply to public roads within Jones County. Speed limits on all paved roads at Little Creek are **13 Miles Per Hour**.
3. To the fullest extent allowed by law, I agree to **WAIVE, DISCHARGE AND RELEASE FROM LIABILITY** Little Creek, its owners, members, officers, directors, agents or employees from **any and all liability** on account of or resulting from Injuries and Damages in any way connected with my visit to Little Creek, even if caused by the negligence of Little Creek, its owners, members, officers, directors, agents or employees, in any way connected with my visit to Little Creek.
4. I further agree to **HOLD HARMLESS** Little Creek, its owners, members, officers, directors, agents or employees from any claims, damages, injuries or losses caused by my own negligence while participating in activities during my visit to Little Creek, and I understand that this assumption of risk and release is binding on my heirs, executors, administrators and assigns, and includes any minors accompanying me while visiting Little Creek.
5. I have read and fully understand this document in its entirety and I freely and voluntarily assume any and all such risks of such Injuries and Damages and, notwithstanding such risks, agree to participate in activities during my visit to Little Creek.
